In the name of God Amen I William Pope of Ridg w[i]thin the p[ar]ish of Chilmarke Husbandman being of good and p[er]fect memory at this present mo[m]ant (god bee thanked for it) doe make and ordeine my last will and testament in manner and forme following first I geve and bequeath my soule into the hands of Almighty god mine only [?] and redeemer and my body to be buried in the church or churchyard of Chilmarke.

Item I geve and bequeath to the like church of Chilmarke twelve pence

Item I geve and bequeath unto Joane Fricker and to Lawrence her sonne six pence

Item I geve and bequeath unto the wife of George Dominick six pence

Item I geve and bequeath unto Ambros Frickers three children twelve pence

Item I geve and bequeath unto Rob[er]te Lawes twelve pence and to any one of his children twelve pence

Item I geve and bequeath unto Mary Fricker the daughter of John Fricker of Sedghill one sheepe

Item I geve and bequeath unto brother Richard Pope his three children twelve pence a peece

Item I geve and bequeath unto xpofer Lewis and his sister twelve pence a peece

Item I geve and bequeath unto Margaret the daughter of my sister Edith twelve pence

Item my will is that Edith my wife sall have occupy and enjoy my halse yeares lande w[i]th th[e] [a]ppurtenances in Bystops f[?] [?] for terme of yeares for remaining yeares of ye saul terme as the said [?]th my wife sall for[?] to line And after her decease I geve and bequeath the reshone of the yeares of the lease then not expired unto Henry Fricker the younger sonne of the said Henry Fricker my brother in law

Item I geve and bequeath unto the three children of Henry Bowles of Knook forty shillings a peece to be paid unto each of them at the age of one and twenty yeares

Item I geve and bequeath unto unto John Bomide of F[?]ill one bushell of wheate and one bushell of barley

And I do make and ordaine my saide well and beloved wife my whole and sole Executrix of this my last will and testament to whome I geve and bequeath all and singular my goods Chattels debts and chattels moveable and unmoveable what over [?] I make and ordaine my said brother in lawe Henry Fricker of Tisbury and Henry Bowles of Bystops [?] ov[er]seers of this my last will and testament to see the [?] p[er]formed accordingly [?] for their paines and expenses I geve and bequeath to each of them twelve pence written the twentieth day of September in the yeares of the raigne of our Sovereigne Lord James by the Grace of god of England Scotland France and Ireland King defender of the faith viz of England France and Ireland the tenth and Scotland the sixe and fortieth 1612
