**In the Name of God Amen**, I Ann Pope of the Hamlet of Fyfield in the Parish of Overton in the County of Wilts Widow being of sound and disposing Mind Memory and Understanding do make and ordain this my last Will and Testament in manner and Form following (that is to say) First I will and direct that all my just Debts and Funeral and Testamentary Expenses be fully paid and satisfied by my Executors hereinafter named and after Payment and Satisfaction thereof and Subject thereto then I do hereby give devise and bequeath unto my Son Luke Pope All that my Freehold Messuage Tenement or Public House wherein I now dwell situate standing and being in the High Road in Fyfield aforesaid and commonly called or known by the Name or Sign of the Fighting Cocks, with all and singular the Hereditaments and Appurtenances to the same belonging **To Hold** the same unto my said Son Luke Pope his Heirs and Assigns for ever. Also I give and bequeath unto my said Son Luke Pope the Sum of Ten pounds of lawfull Money of Great Britain to be paid him by my said Executrix as soon as conveniently may be after my decease. All the Rest and residue of my Estate and Effects whatsoever and wheresoever and of what Nature or kind soever both real and personal Stock in Trade Household Goods and Implements of Household Bonds Bills Notes Book Debts and other Effects I do hereby give devise and bequeath unto my daughter Sarah Pope to and for her own Use and Benefit and to be at her own sole Use and Disposal absolutely And I do hereby nominate constitute and appoint my said Daughter Sarah Pope full and sole

Executrix of this my Will hereby revoking and making utterly void all former and other Will and wills by me at any Time heretofore made and do declare this and this only to be my true last Will and Testament. **In Witness** whereof I the said Ann Pope the Testatrix have to this My Will contained in one Sheet of paper set my Hand and Seal this Ninth day of April in the year of our Lord one thousand seven hundred and ninety two
