Thanks be given to god Therefore Calling unto mind the mortality of my body and knowing It Is apointed for all men once to dye doe make and ordain this my Last will and Testament that Is to say Principally and first of all I give and Recommend my Soul Into the hands of god that gave It and for my body I Recommend It to the Earth to be buried In Christian like an decen maner att the Diseretion of my Executor nothing doubting but att the general Resurrection I shall receive the Same again by the myty power of god and as touch Such worldly Estate where wit It hath pleased god to bless me In this life I give advice and Didpose of the Same In the following maner and form **Imprimus**: I give and bequeath to my Daughter Mary: Daughter Mary Stanmore my feather bed and Every Thing be Longing to It, and my Cheast and my begest Brass pott and one of my pewter platters If Ever she have or when Ever shee have accasion to make use of It: and I further bequeath her the said Mary Stanmer tenn pounds of good and Lawfull money of England to be left In the hands of my Son Nicholas Pope for and toward the breeding of her up , allso I give to her the Sum of fortey shillings of good and Law full money of England to be paid to her when Shhee curns to the age of Twenty one years old

Item I give and bequeath to my Son Nicholas Pope – Daughters Mary Joan Jane Sary and Rebecka the Sum of twenty Shillings a piece of good and Lawfull money of England

Item I Give to my Son in Law Edward Stanmer of fifel three poundsthat he ows to me

Item I give to my Dearly beloved Son Nicholas Pope whom I likewise Constitute make and ordayne my only and sole Executor of this my Last will and Testament all and Singular my goods and Chattels and Tennements Revoke and disanul all and every other former Testamnets Wills and Lagacies Requests and Executors by me In any wais before this time named – my Last will and Testament
