In the name of God Amen The first day of September In the year of our Lord one Thousand Seven hundred and Thirteen In the Twelfth year of the Reign of our Sovering Lady Anne by the grace of God Queen of Great Britain France Ireland I Thomas Pope of Lockeridge in the parish of Overton In the Countey of Wilts Shepherd Being Sick and weak in bodey butt of perfect mind and Memory thinks be given to god Therefore Calling to mind the mortality of my bodey and knowing that it is Apointed for All men owe to died make and ordain this my Last will and Testament That is to say principally and first of all I give and Recommend my Soul into the hands of god that gave it and for my Bodey I Recommend It to the earth to be buried In Christian like decent manner att the Discretion of my Executors nothind doubting Butt I Shall Att the general Resurection Receive the Same Again by the mighty Power of God and as Touching Such wordly Estate wherewith It hath pleased god to Bless me with in this life I give advice and dispose of in the following manner and form

Imprimus I give to my Son in Law Thomas Mathews the plot og ground where his house abd garden Now Stands upon dureing the lives that I now holds it by. I give to him allso Liberty to draw water att my well he being att half the Charge of the bucket and Rope; I allso Give and further be queath to him my Low bedsed with the bed and beding belonging to it and one Round Civer and a Coffer.

Item I give to my Son John Pope my house and Barn and Garden and Close and two half Acres of Land in the Common fields of Overton onely I serve my Dwelling house with the barn and land and all before mentioned Belonging to my Lease holde Estate: that my Son in Law Phillip Green Shall Quietly an peasably Enjoy for one whole year after my deceace: without aney melistation or Contradiction of my Son John Pope aalso I give onto my befores siad house and Land the Sum of fouer pounds of Good and Lawfull money Great Brittain To be paid in the following manner and form that is to say it Shall be payed twenty Shillings a year for foruer year and the fouer year to begin when my before named son John Pope Shall Take to my before mentioned Estate; and the first Twenty Shillings which shall be payd I give to my Son in Law Phillip Green and his wife and the other Three pounds I five to my Son William Pope And to my Son in law Phillip Green and his wife, to be paid them Twenty Shillings a year.

Item I give and further bequeath to my son John Pope my Table Board and binches

Item I give to my son William the brass Pan an my begest Kittel brass pot

Item I give and bequeath to my Son in law Phiilip Green all the Rest of my money Goods and Chattels, making him Executor of this my Last will and Testament and I doe here by Utterly disalow Revoke disarcull all and Every other Testamnet wills and Legacyes Requests and Executors by me in any ways before this time named wiied and bequeathed Ratifying and Confirmin this and no other my Last will and Testament In Witness wheare of I have here [right edge missing] my hand and Seal the day and year above written
