- Anna Bendrey wife of John Dore Bendrey
- George Wallis and Richard Tooth Bendrey lived in Wroughton in 1877
- Richard Tooth Bendrey died 1889, aged 72 - lived at Marlborough Road, Wroughton (born Birmingham). Brother of John Dore Bendrey
- Ellen Wallis cousin of John Dore Bendrey
- Ann Avery, Spinster of Kings Norton, Worcestershire
- Alice daughter, Thomas (d 23 Mar 1865) and Walter (15 May 1875) sons of of Richard Tooth Bendrey

**This Indenture** made the twenty fifth day of August One thousand eight hundred and seven seven Between **George Wallis** of Wroughton in the County of Wilts Gentleman of the one part and **Richard Tooth Bendrey** of the same place Gentleman of the other part **Whereas** John Dore Bendrey formerly of Coalbrook Cottage, Kings Norton in the County of Worcester Gentleman deceased duly made and executed his last Will dated the twenty six day of September One thousand eight hundred and sixty four whereby after bequeathing certain pecumary legacies the Testator bequeathed an annuity of twenty seven pounds free from legacy duty to his cousin Ellen Wallis the wife of the said George Wallis to be paid to her during her life for her sole and separate use free from the debts and control of her then present or any future husband And bequeathed an annuity of seventy five pounds free from legacy duty to his brother the said Richard Tooth Bendrey for his life and from and after his decease An annuity of Fifty pounds free from legacy duty to his wife Anna Bendrey for her life for her sole and separate use but subject as to the said two last mentioned annuities to a proviso for making void the same on the said Richard Tooth Bendrey and Anna Bendrey or either of them doing permitting or attempting to do any act whereby the said annuities would become vested in or payable to some other person And the Testator devised all his real estate of every description (including chattels real) except what he otherwise disposed of by that his Will or any Codicil thereto unto and to the use of David Dimpleby of Birmingham in the County of Warwick Gentleman and the said George Wallis their heirs executors and administrators respectively And the Testator bequeathed all his personal estate except chattels real and what he otherwise disposed of by that his Will or any codicil thereto unto the said David Dimpleby and George Wallis Upon trusts as to the said real and personal estate for sale and conversion into money with a discretionary power to them to postpone such sale and conversion so long as they should think fit And upon and with trusts and powers as to the said real and personal estate and the moneys arising from sale thereof for paying his the Testator's debts and the said legacies and annuities and subject thereto and to the trusts and powers for paying the said annuities certain trusts were thereby declared as to the residue of the Testator's real and personal estate in favor of his Nephews Thomas Bendrey and Walter Bendrey and his niece Alice Bendrey all children of the said Richard Tooth Bendrey successively for their several lives and in favor of their issue successively as in the said Will declared with the ultimate trust after their decease and failure of their issue in favor of the said Richard Tooth Bendrey absolute And by his said Will the Testator declared that if the Trustees thereby constituted or either of them should after his decease die or be abroad or desire to be discharged or refuse or become incapable to act then and in every such case it should be lawful for the surviving or continuing Trustees or Trustee for the time being or for the acting Executors or Executor administrators or administrator of the last surviving continuing Trustee (with the consent of the Tenant for life of his (Testator's) Trust estate if of full age) to appoint a new Trustee or Trustees in the place of the Trustee or Trustees so dying or being abroad or desiring to be discharged or refusing or becoming incapable to act as aforesaid And the Testator appointed the said David Dimpleby and George Wallis Executors of his said Will **And whereas** by a first Codicil to his aid Will dated the fourteenth day of November One thousand eight hundred and sixty four the Testator bequeathed an annuity of Fifty three pounds ten shillings free of legacy duty for her life to Anne Avery Spinster then residing with him payable out of his said Trust estate but did not otherwise alter the trusts of his said Will to the effect herein before recited **And whereas** by a second Codicil to his said Will dated the tenth day of January one thousand eight hundred and sixty five the Testator declared that the said annuity given to the said Ellen Wallis should be Thirty pounds instead of Twenty pounds and that the said contingent annuity to the said Anna Bendrey should be Forty

pounds instead of Fifty pounds but in other respects he confirmed his said Will as altered by the first codicil **And whereas** the Testator died on the sixteenth day of May one thousand eight hundred and sixty five without having revoked his said Will and two Codicils which on the nineteenth day of June one thousand eight hundred and sixty five were duly proved in the District Registry of Her Majesty's Court of Probate by the said David Dimpleby and George Wallis **And whereas** at the death of the Testator his real and leasehold estate consisted of the property described in the Schedule hereunder written and in due time after his death the said David Dimpleby and George Wallis as Executors of his said Will received and collected his ready money and all debts owing to him on personal security and as Trustees of his said Will sold such parts of his said real and leasehold estates as are mentioned in the first part of the said Schedule and at the respective times therein mentioned and as such Trustees and Executors out of the money, s so arising paid his funeral expenses and debts and the said legacies and the expenses of realizing and administering his said estate and all the duty payable in respect of the said legacies and annuities and from time to time invested the residue of the money's so arising wholly in the purchase of Three per cent Consolidated Bank Annuities and such investments amounted together to the aggregate sum of Four thousand six hundred and forty one pounds nine shillings and ten pence Consolidated Bank Annuities **And whereas** the Annulents mentioned in the said Will and Codocils are all now living and the said David Dimpleby and George Wallis out of the income of the Testator's said real and personal estate duly paid the said annuities half yearly and the same have been paid up to the sixteenth day of May last as the said George Wallis with respect to the yearly annuity of Thirty pounds payable to Ellen his wife and the said Richard Tooth Bendrey with regard to the annuity of Seventy five pounds payable yo himself do hereby severally acknowledge **And whereas** the said David Dimpleby and George Wallis as such Trustees as aforesaid duly applied the residue of the said Income in or towards the maintenance of the said Thomas Benfrey and afterwards on his death which happened on the twenty third day of March one thousand eight hundred and sixty eight of the said Walter Bendrey until his death which happened on the fifteenth day of May one thousand eight hundred and seventy five as the said Richard Tooth Bendrey hereby acknowledges **And whereas** on the eighteenth day of June one thousand eight hundred and seventy out of the said sum of Four thousand six hundred and forty one pounds nine shillings and ten pence Consolidated Bank Annuities sold the sum of One hundred and thirty seven pounds and six shillings and applied the proceeds thereof in apprenticing the said Walter Bendrey to Joseph Armstrong Esquire

**And whereas** on the application in Chancery of the said Alice Bendrey then an Infant and entitled for her life to the income of the Trust estate of the Testator His Honor Vice Chancellor Wickens on the eleventh day of March one thousand eight hundred and seventy three ordered that the sum of thirty five pounds be allowed for the purchase of a Pianoforte for the said Alice Bendrey and that the same be passed by the said David Dimpleby and George Wallis by sale of a sufficient part of the Consolidated Bank Annuities standing in their names in the Books of the Bank And that the sum of Thirty pounds (including Fifteen pounds which had already been paid) be allotted for the past maintenance and education of the said Infant up to the fifteenth day of May one thousand eight hundred and seventh three And that a sum not exceeding Forty pounds per annum be allowed to the said Richard Tooth Bendrey for her future maintenance and education for and during her

**Minority** **And whereas** *in pursuance of such order the said David Dimbleby and George Wallis sold out the sum of Thirty eight pounds two shillings and six pence Consolidated Bank Annuities and invested the net proceeds thereof in the purchase of a Pianoforte for the said Alice Bendrey and in further pursuance of such order the said allowance for her maintenance and education has been paid out of the Income of the Testator's Trust Estate up to the sixteenth day of May last as the said Richard Tooth Bendrey hereby acknowledges* **And whereas** *the said David Dimbleby died on the eleventh day of April last and the said George Wallis desires in exercise of the recited power for that purpose given to him by the said Will to appoint the said Richard Tooth Bendrey to be a Trustee in his place and the said Richard Tooth Bendrey has agreed to accept such Trusteeship* **And whereas** *the real and personal estate of the Testator is now represented by the real and leasehold estate described in the second and third parts of the said Schedule hereto and of the sum of Four thousand four hundred and sixty six pounds one shilling and four pence Consolidated Bank Annuities now standing in the name of George Wallis* **And whereas** *it is intended that the said sum of Four thousand four hundred and sixty six pounds one shilling and four pence Consolidated Bank Annuities shall be transferred into the names of the said George Wallis and Richard Tooth Bendrey and that by these presents the real estate of the Testator being that which is described in the second part of the Schedule hereto shall be assured so as to become vested in the said Richard Tooth Bendrey jointly with the said George Wallis but as to the two leasehold ground rents of Eighty pounds sixteen shillings and eight pence and Eleven pounds five shillings mentioned in the third part of the said Schedule which by Indenture dated the twenty sixth day of October one thousand eight hundred and fifty eight became vested in the said Richard Tooth Bendrey as Trustee for the Testator John Dore Bendrey and which are now and it is desired that they shall remain vested in him* **Now this Indenture witnesseth** *that by virtue and in exercise of the power or authority given by the said Will of the Testator John Dore Bendrey and of every other power or authority in anywise enabling him in this behalf* **he** *the the said George Wallis* **doth** *by these presents nominate and appoint the said Richard Tooth Bendrey in the place of the said David Dimbleby to be a Trustee of the Will of the said John Dore Bendrey deceased for the execution of the trusts and and for the purposes of the said Will or such of them as are now subsisting and capable of taking effect* **And** *the said Richard Tooth Bendrey doth hereby declare his acceptance of the said trusts* **And** *they the said George Wallis and Richard Tooth Bendrey do hereby declare that they will hold the said sum of Four thousand four hundred and sixty six pounds one shilling and four pence Consolidated Bank Annuities* **Upon the Trusts** *and subject to the powers applicable thereto or under or by virtue of the said Will of the said John Dore Bendrey deceased* **And this Indenture further Witnesseth** *that in obedience to the direction in the said Will contained* **he** *the said George Wallis* **doth** *hereby grant and convey unto the said Richard Tooth Bendrey and his heirs All the messuages land tenements and hereditaments described in the second part of the Schedule hereunder written which are all situate in the Parish of Wroughton in the County of Wilts and all other real estate and premises by the Will of John Dore Bendrey devised to the said David Dimbleby and George Wallis their heirs and assigns upon trust as aforesaid (if any) with the rights easements and appurtenances respectively belonging thereto or heretofore enjoyed therewith* **To hold** *the said premises unto the said Richard Tooth Bendrey and his heirs* **To the use of of the said George Wallis and Richard Tooth Bendrey their heirs and assigns** **Upon the Trusts** *and with the*
