Chief Steward of the said Manor and (She the said Mary being by the said Deputy Steward first solely and separately examined apart from her Husband and freely and voluntarily consenting thereto) Did surrender out of their and each of their hands into the hands of the Lady of the said Manor by the hands of the said Deputy Steward by the rod in the presence of Charles Buck Gent. A person of credit witnessing the same All and every the Messuages Lands Tenements and Hereditaments whatsoever of them the said Jonathan Bond and Mary his wife and each of them holden of the said Manor by Copy of Court Roll with the Appurtenances and the reversion and reversions remainder and remainders thereof And all the Estate Right Tithe Interest Property Claim and Demand whatsoever of them the said Jonathan Bond and Mary his wife and each of them of in and to the same and every part and parcel thereof To the sole and absolute use and behoof of Daniel Scott of the City of Norwich Gentleman his Heirs and Assigns for ever **Now** to this Court in his proper person cometh the said Daniel Scott and prayeth the favor of the Lady of this Manor to be admitted Tenant to the Lands and Tenements to his use as aforesaid sworedred that is to say To a messuage or Tenement and four acres of Copyhold Land of this Manor with the Appurtenances in Stalham (which premises the said Jonathan Bond and Mary his wife/late named Mary Read (had and took up to them or the Survivor of them and the Heirs of such Survivor after the death and as Daughter and Heir at Law of John Read her Father deceased, as to her right and inheritance, at a General Court Baron held in and for the said Manor the thirty first day of October One thousand seven hundred and seventy one, as by the rolls of the said Court reference being thereto had may appear) And the Lady of this Manor by the hands of the said Steward doth grant and deliver seizen of the Lands and Tenements aforesaid with their appurtenances by the rod To Hold to him the said Daniel Scott and his heirs according to the form and effect of the said sworedred of the Lady of this Manor at her will according to the custom of the said Manor by the ancient rents customs and services for the same due and of right accustomed saving the right of every one &c. and he pays to the Lady a fine &c. And the said Daniel Scott is thereof admitted Tenant in form aforesaid but his frealty is respited &c.
