Introduction

The Pope link to the White family is through the marriage of Jane White (1797-1874), daughter of Benoni White, senior (1801-1866) to William Pope (1792-1851) in 1825.

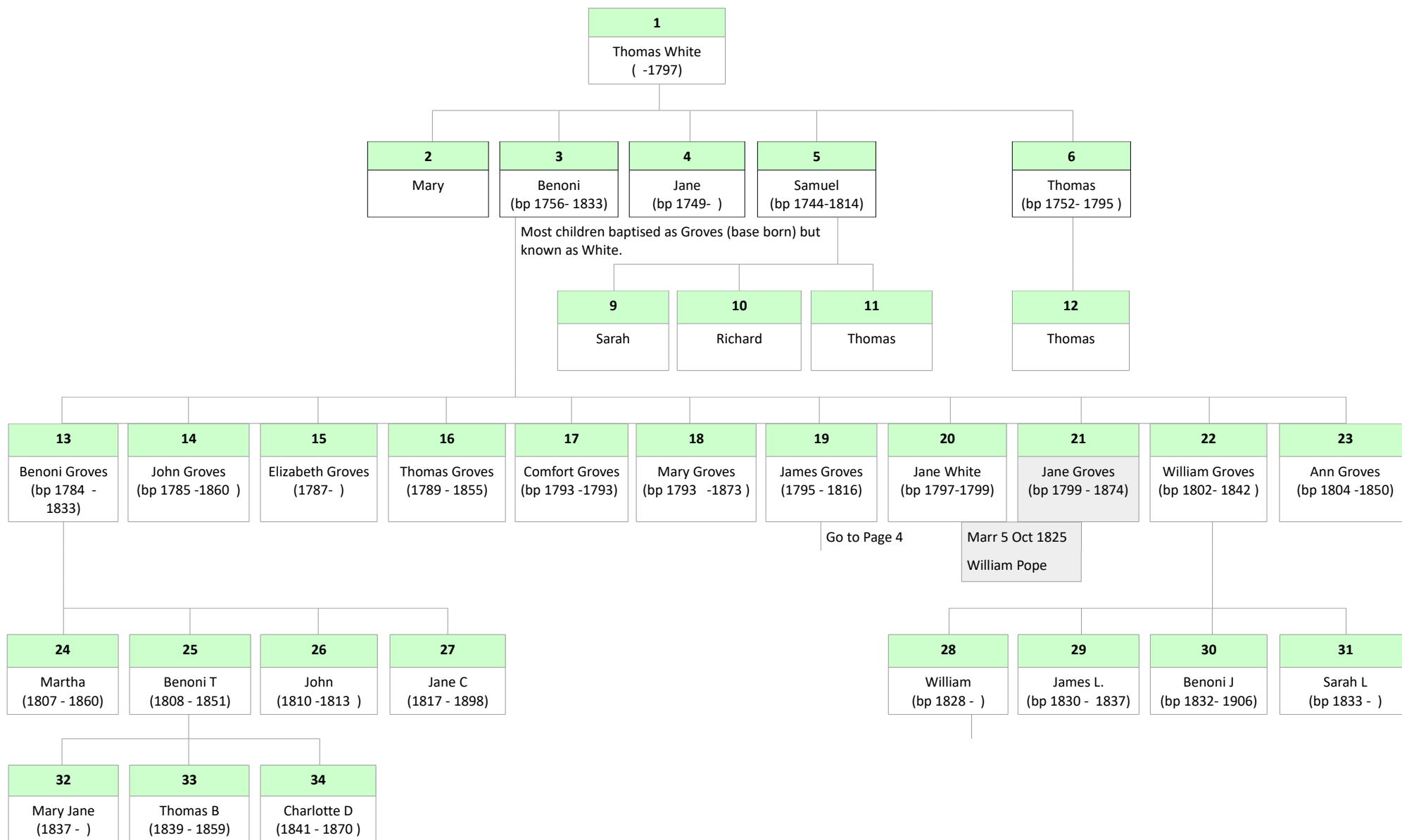
Devizes was divided into three Parishes. St. Johns, St. Marys and St. James. The parish of St. James was also known as Southbroom and prior called St James Chapelry, parish of Bishops Cannings.

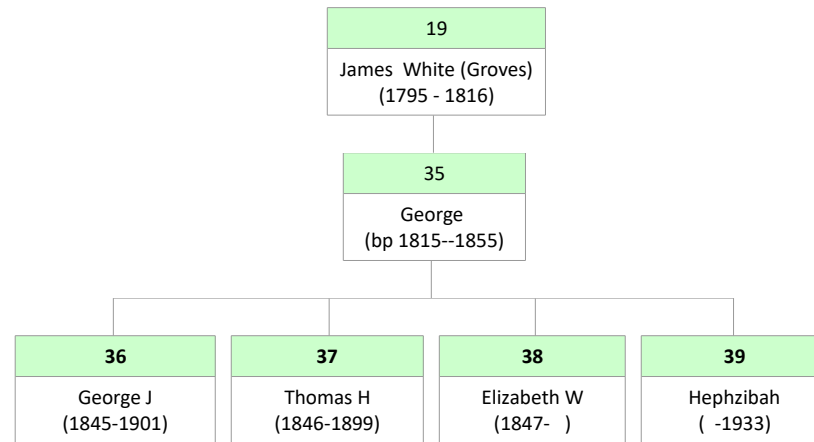
There was a Benoni White baptised 27 March 1719 and buried 12 Jun 1719 at Potterne, Wilts. father was named Samuel. Any connection?. Other than that, there are too many John, Samuel and Thomas forenames in Potterne and Devizes to identify the correct persons for the early part of this tree.

Depending on records, Benoni also spelt as Beniomi, Bonoamni, Benioni and Berroni etc.

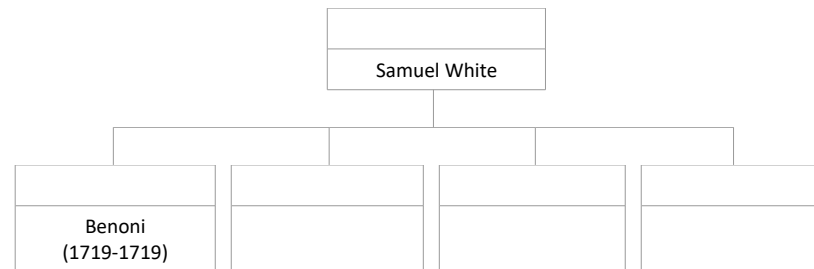

1. Thomas White

Thomas White was baptised ? and was buried 21 Jan 1797, aged 82 yrs, Devizes St. John The Baptist, Wilts.

General Notes:

Could the baptism be at Potterne on 19 Apr 1738, father named Thomas?

Last Will and Testament was written 11 Jan 1797

Beneficiaries: Mary (dau), Benoni (son), Jane (dau and wife of James Godwin), Samuel (son), Thomas (grandson and son of late son Thomas)

Estates mentioned: Messaues, hereditaments and gardens lying in Chapelry of Saint James with the apportionments now in the possession of John Paine and now in occupation of Thomas Moore.

Sole Executor: Benoni (son) who was sworn before the Surrogate at Devizes 14 Jul 1797.

Married **Eleanor Glass** on 7 Feb 1738 at Devizes St. John The Baptist.

Eleanor was baptised 18 Feb 1711 at Devizes St. Mary's.

Parents: William & Eleanor Glass.

They had 5 Children: **Mary, Benoni, Jane, Samuel** and **Thomas White**.

2. Mary White

Beneficiary in the Last Will and Testament of Thomas Pope 11 Jan 1797 (father).

Beneficiary in the Last Will and Testament of Thomas White dated 26 Jun 1795 (her brother) and who died 1795 - Mary White (sister and spinster) .

3. Benoni White, senr.

Benoni White was baptised 4 Mar 1756 at St. James, Southbroom, died 1 July and buried 5 Jul 1833 at Devizes St John the Baptist.

Occupation: Master Builder and an Architect, Gentleman.

Beneficiary in the Last Will and Testament of Thomas White 11 Jan 1797 (father), Sole Executor.

Owned property in Sidmouth Street, amongst others (named after Viscount Sidmouth 1757-1844).
- St James Church, Devizes , An enlargement began in 1815 with an unexecuted design by Richard Ingleman for an enlarged chancel grafted onto the old nave and aisles, but eventually full rebuilding of the nave, aisles and chancel was agreed. Work began in July 1831, and the church re-opened on August 10, 1832. The architect was reportedly a 'Mr Pennistone', presumably John Peniston of Salisbury. However, Benoni White, a Devizes architect, seemingly drew the actual plans. (Colvin suggests that Benoni was the designer and Peniston took over after Benoni's death; however, Benoni died in July 1833, almost a year after rebuilding was complete. The split of responsibility for the design is unclear) . Source: Historic England.

Last Will and Testament was written 4 Jun 1833 and probate 8 Oct 1833.

Beneficiaries Elizabeth (wife), his eight children Benoni, John, Elizabeth (wife of Richard Mullings), Thomas, Mary (the wife of Thomas Carter), Jane (the wife of William Pope), William and Ann (wife of John Cox), George (son of late son (James), Sarah Harris (widow and wife of late brother Samuel), Richard (nephew), Thomas (son-in-law, ironmonger). Others mentioned: John Paine, Richard White and Charles Neate (living in properties situated within St James Chapelry), William Hunt Grubb Esq.

Executors: Benoni White and Thomas Carter
Estate mentioned in will: Dwelling house, garden and premises. Other Freehold, messuages, lands, tenements and hereditaments situated in Chapelry of Saint James. Leasehold messuages, lands, tenements and premises Devizes. Two messuages tenements or dwelling houses and premises in or near the High Street in the Parish of Saint John the Baptist in Devizes

Administration Bond dated 12 Sep 1833, the commission was duly executed at Devizes on 4 Oct 1833. The Oath was administered to Thomas Carter, the surviving Executor. Effects sworn sub £3000.

The headstone reads "Sacred to the memory of - Benoni White sen. - who departed this life 1st July 1833 – in the 79 th year of his age - Also of – Elizabeth his wife – who died 6th April 1836 – aged 71 years"

Does not seem to have married **Elizabeth Groves**, but had base born children by her. (father's name not given). On parish register baptised using mothers surname, but known as White.

Did they marry after 1797?

She was born c1765 , died 4 Apr, age 71 and buried 8 Apr 1836 at St

ALBION PLACE, DEVIZES, 1st JAN., 1833.
BENONI WHITE, ARCHITECT, SURVEYOR, and BUILDER, returns his sincere thanks to the Nobility, Gentry, and Public in general, for the support he has received from them for many years past, and begs most respectfully to inform them, that he has this day DECLINED the business of CARPENTER, JOINER, and BUILDER, in favour of his Son.
B. 5. Samuel White

Samuel White was baptised 22 Apr 1744 at Southbroom St. James and died 1814.

Beneficiary in the Last Will and Testament of Thomas Pope 11 Jan 1797 (father).

Married **Sarah Harris**.

Sarah Harris was beneficiary in the Last Will and Testament of Benoni Pope (late Samuel's brother) 4 Jun 1833 and probate 8 Oct 1833.

Known Children: **Sarah, Richard** and **Thomas White**.

6. Thomas White

Thomas White was baptised 22 May 1752 at Southbroom St. James and was buried 25 Jul 1795 at Devizes St. John the Baptist (aged 43 yrs).

Parish Register records parents as Thomas and Eleanor.

General Notes:

Not a Beneficiary in the Last Will and Testament of Thomas Pope of 11 Jan 1797 (father). However, Thomas (grandson and son of late son Thomas) was a beneficiary.

13. Benoni White, junr. (Groves)

Benoni White (jnr) baptised 17 Sep 1784 at Devizes St. Mary, died 28 Jul 1833 and buried 2 August 1833, Devizes St. Mary.

Base born. Parish Register as Benoni White Groves and Benjamin White Groves, both baptised same day. Mother Betty Groves. Also an entry for Benoni White.

Betty Groves spinster of Devizes St Mary, by Benoni White, a carpenter of St James, Southbroom.

Is Benjamin White Groves a correction?.

General Notes:

- 🌀 1799, soldier in the Devizes Troop, Royal Wiltshire Yeomanry. Noted as residing at Devizes Green but the record does not indicate if it is Benoni junior or senior.

- Wiltshire Quarter Sessions, 5 Oct 1807, Prison. Carpenter.
- All Saints, Enford. Undertook repairs because of lightening damage in 1818 (1818-1831).
- 14 Nov 1821, Builder, initiated into Lodge of Temperance & Morality (Freemasons).
- All Saints, Enford - The church was restored in 1825-30 by Benoni White of Devizes and in 1892-3 by CE Ponting.
- In 1827 built 2 houses in Long Street adjoining the churchyard of St John and previously as a house in New Port. These were possibly designed and built by Benoni White who was party to several deeds.
- St Mary the Virgin, Bishop Cannings, Undertook reseating/repairs (1827-1829).

- Mortgage on property (?) in West Lavington, date 1830.*

- The New Assize Courts were built in 1835 following the raising of a subscription from townspeople and neighbouring gentry for a law courts building. It was designed by T. H. Wyatt in the Classical style with Ionic pillars The tenders of Messrs. Young and Benoni White of Devizes have been accepted, for the erection of the new Assize Courts. The work is to be completed by the 1st of June next, and active preparations are making for proceeding with it immediately. The Loudon's Architectural Magazine, Volume 2.

[‡] Mary Patient (1834 – 1905) is the daughter of Joshua Patient and Sarah Phillips.

Sarah Phillips is the sister of James Phillips (1794 – 1845).

James Phillips married Mary Tubb (1798 – 1873) on 5 July 1819 at Bishop Sutton. (Mary Tubb's mother Sarah Freemantle married John Moore 1801 so the daughter was referred to as Mary Tubb Moore.)

Mary Tubb (Phillips) married Benoni Thomas White 1846 at Devizes and when he died in 1851, she lived with Thomas and Mary Carter.

Mary Patient is living with Thomas and Mary Carter in the 1861 and 1871 census.

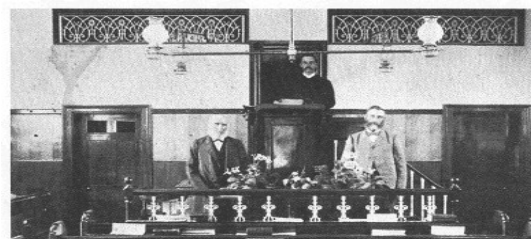

64. The Mount Zion Baptist Chapel lies on the west side of Leading Street. It was built in 1828, following a period when the founders had conducted their services in hired premises in various parts of Meopham and Luddesdown. This interior view of the chapel was taken in the late 19th century, and shows the minister, the Reverend William Pope, posing with his two Deacons, brothers named Crowhurst. The lighting was, of course, by oil lamps, as electricity did not reach the village for some forty or fifty years after this picture was taken.

Graveyard is now a car park and the memorial stone is now part of the pathway in front of the church porch. This mentions Jane as wife and Elizabeth a daughter who died in 1833.

Biography:

At about 1820, he went to preach at Grove, Wantage. He was baptised at Devizes in 1822 and afterwards acted as pastor to a small Baptist Church at Baydon.

An Highworth Meeting House Certificate was issued 18 April 1826 to George Peapell's Dwelling House, Baptist Denomination. Others mentioned on the Certificate were Edmund Hedges, Richard Clack, Pator Thompson, Thomas Lawrence and William Pope.

He started to give occasional sermons at Meopham, the 1st occurring in 1832 and then 1833. Was asked to become Minister and commenced Sep 1833. He also preached many times in the open air at Cobham, and occasionally in a cottage in the village.

The following passage was taken from "A Brief History of the Planting of the Baptist Church, Meopham" published in 1866.

"The mortal remains of Mr Pope were buried in the chapel grave-yard on 28 March 1851, there being a large attendance of the members and friends. Mr Pope left a widow and eight children to lament their loss" *[moving further in to book]*

"The following is a brief outline of Mr Pope's early days from a biographical sketch of Mr Pope in 'Life Reviewed and Death Surveyed', by Mr Cox, now of Ipswich :- Mr Pope was born at Bishopstone in Wiltshire. His father was a small farmer; he was and only son but had several sisters. When about sixteen years of age it pleased God to begin a work of grace on his heart. At that time there were a few poor people that met together in the village for prayer. He being aware of this, went to the door and listened, and a Christian man noticed him, spoke a kind word and encouraged him to persevere in seeking the Lord. This friendly countenance and counsel cheered him, and he was enabled to manifest decision for God. And when he was about twenty one years of age, he began to speak to the redeemer of his soul to others, and preached tolerably regularly in the villages around, and continued to do so for several years, labouring gratuitously and contributing from his own pocket to the cause of God. About the year 1820 he went to preach at Grove, near Wantage, where he ministered every other Lord's-day; the other Sabbaths being occupied in preaching elsewhere. He was baptised at Devizes, in the year 1822, and afterwards acted as pastor to a small Baptist church at Baydon, Wilts, where he so continued until his removal to Meopham, in 1833".

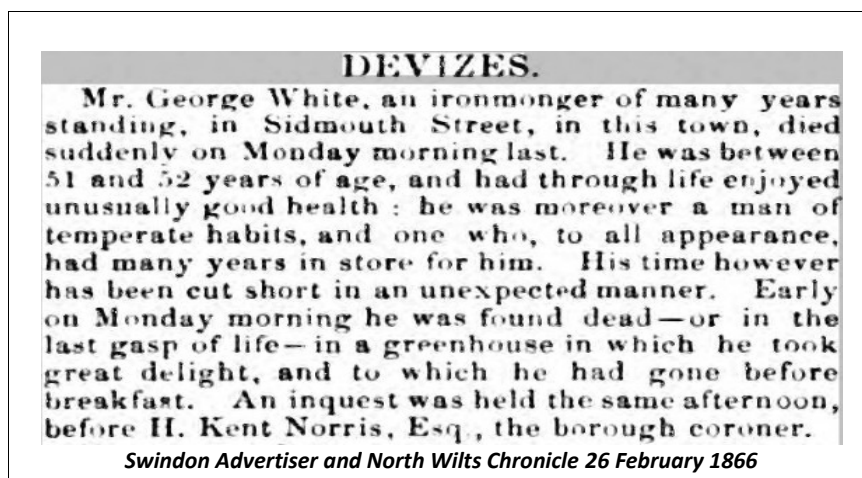

SUDDEN DEATH.—Mr. George White, ironmonger, of Sidmouth-street, died very suddenly on Monday morning last. The deceased, who was upwards of 50 years of age, appeared to be in his usual health on the morning in question, and went to his garden behind the Baptist chapel, where it was his custom to spend some time every morning. Some time afterwards, when one of his assistants went to call him to breakfast he was found insensible near the entrance to the greenhouse; and though medical aid was immediately procured he expired almost immediately after being removed to his residence. The curious fact that a number of canaries kept in the greenhouse were all found dead led at first to the suspicion that they and Mr. White had been suffocated by the fumes of a charcoal stove, but this idea was entirely dispelled by Mr. Thorneley, a surgeon, who was called in, and who stated that the death of Mr. White was the result of congestion of the brain, "brought on by sudden exposure to cold on an empty stomach." An inquest was held on view of the body on Monday, when the jury returned a verdict to the effect that the deceased had died "by the visitation of God."
